Course Description:

This is the first (chronologically) of two courses examining the history of built environments. This introductory survey will address premodern (or non-modern) traditions in various places, with a primary focus on the roots of modernity in the 19th century.

Course Hours: 3 units; (3-0 Lecture)

This course will take place **in-person** and **online** via Desire2Learn (D2L). Students are required to participate in-person in class discussions and other activities (on Tuesdays and two Fridays), and to complete asynchronous learning tasks using the D2L learning environment.
