Course Description:

We cannot predict the ways that people will use the built environment, particularly given the life span of buildings and how fluid our interactions are in those spaces over time. This is why it is difficult to differentiate between design choices that will have a negative impact on people with disabilities in a way that most would find intolerable, like an inaccessible voting location, and the design choices that might be considered an inconvenience, like an inaccessible washroom in a restaurant. This block week course will explore the law of the built environment and how the historic segregation of people with disabilities is reinforced by this area of law. Students will be introduced to inclusive design through case studies and will consider the architect's role is designing for every body.

Course Learning Outcomes:

Upon completion of this course, students will:

- Understand the federal government's role in drafting model building code standards since the 1940s and accessible standards since the 1960s;
- Develop familiarity with the ways that the law of the built environment in Canada privileges able-bodiedness; and,
- Think critically about the role of the architect in designing for all bodies.

Online Delivery:

This course will take place online via Desire2Learn (D2L) and Zoom. Students are required to participate in the asynchronous learning tasks using the D2L learning environment and synchronous Zoom sessions. If unable to participate live due to unforeseen circumstances, inform the instructor in advance to work out an alternative participation activity (e.g., watch the recordings, submit a brief reflection, and actively contribute to the follow-up online discussion).

Learning Resources:

All required readings will be on the course D2L site.
