Course Description

This course will explore the medium of the podcast as a way to discuss architecture and architecture adjacent topics. Students and the instructor will work together to create one produced podcast episode over the course of the term.

Students will explore and document other design focused podcasts for content, structure and clues about how we discuss design through sound, before starting from scratch with the production of a "one good episode".

Course Hours: 3 units – M/T/TH/F 2-6PM

Course Learning Outcomes

Upon completion of this course, students will know and be able to:

- 1. Apply architectural critical thinking practices to the act of communicating about architecture through dialogue and sound.
- 2. Write scripts
- 3. Record and Edit material for a podcast.

Required readings, textbooks and learning materials:

Students will be asked to listen to podcasts each week and report on them to the group. These will be both assigned and self selected.

Technology requirements (D2L etc.):

Editing software for this course is available in both the University of Calgary Library and the Computer Lab. Students can also download the needed software to their personal machines for editing purposes.

Most current laptops will have a built-in webcam, speaker and microphone.

Workshop Safety Training Requirement

Guidelines for Zoom Sessions

Zoom is a video conferencing program that will allow us to meet at specific times for a "live" video conference, so that we can have the opportunity to meet each other virtually and discuss relevant course topics as a learning community.

To help ensure Zoom sessions are private, do not share the Zoom link or password with others, or on any social media platforms. Zoom links and passwords are only intended for students registered in the course. Zoom recordings and materials presented in Zoom, including any teaching materials, must not be shared, distributed or published without the instructor's permission.

Students will be advised before the instructor initiates a recording of a Zoom session. These recordings will be used to support student learning only and will not be shared or used for any other purpose.
