Course Description

Focuses on the synthesis and integration of current landscape technologies, landscape construction materials, plant materials and planting design, using advanced design methods and graphic techniques to address complex issues in landscape architecture. (Calendar description)

Two Billion Trees Studio

"We plant trees, and trees plant us, since we belong to each other, and we must coexist." (Joseph Beuys).

Now more than ever, trees are a vital component of healthy, sustainable, and livable communities. Trees clean water and air, lower urban temperatures, manage stormwater, and provide mental health benefits. Trees also hold spiritual significance for many, particularly within Indigenous cultures.

The federal government has made a commitment to planting 2 billion trees. This comes alongside global calls for planting significant numbers of trees to improve resilience in the face of climate change.

At the same time cities are becoming denser and more urban. Urban infill and affordable housing are priorities for cities that are investing in transit to minimize carbon emissions. Typically, dense developments

provide minimal tree canopy.

Two Billion Trees, engages with the challenge of climate change and urban greening. Two Billion Trees refers to the strategies used to incorporate trees into cities. The research starts by asking several questions: why trees? What are the challenges of urban forests? How do trees contribute? How can greening be implemented in our cities? How do cities have to change to incorporate green elements?

The Two Billion Trees studio examines the competing interests between compact urban form and urban forests that is evident in large cities. The studio will review tree planting initiatives by comparing assumptions and approaches. Students will be asked to apply an initiative of this nature to the City of Calgary, assessing the applicability and expected outcome. Subsequently, the studio will undertake a design exercise to implement significant greening initiatives in selected areas of the city. Design explorations will incorporate public realm initiatives to address climate change and illustrate public realm improvements. Students will be required to examine the technical requirements needed to implement these changes.

Stages

- Environmental Scan (Assignment 1 20%)
- Strategy Development and Large Scale Analysis (Assignment 2 20%)
- Site Specific Demonstration Interim (Assignment 3a 20%)
- Site Specific Demonstration Final (Assignment 3b 40%)

Course Hours: 6 units; F(0-8)

Course Learning Outcomes

- Apply knowledge acquired throughout students' academic career, including site analysis, precedent review and research, concept design, construction documentation, and visual and oral communication.
- 2. Demonstrate open-mindedness and curiosity throughout exploration, engagement, and design process.
- 3. Cultivate an ability to listen to stakeholder input and integrate that feedback in design.
- 4. Develop an ability to work collaboratively, soliciting and offering constructive feedback to drive and influence design.
- 5. Communicate design thinking and ideas visually, verbally, and through narrative.
- 6. Demonstrate a commitment to process, including consideration of alternatives, iteration, evolution in design thinking, and refinement from a big idea to detailed design.
- 7. Gain exposure to landscape architecture in practice.
- 8. Develop an evidence-based approach to decision-making in design that demonstrates the value of landscape architecture.
- 9. Contextualize the role of landscape architecture within the larger social political economic environmental and cultural dimensions of society.
